# **TERMS & CONDITIONS**

# 1. Organizer

**The Esade International Relations, Economics & Politics Challenge** is a promotional competition organized by the Esade Foundation, G-59716761 (registered offices at Avenida Pedralbes, 60-62, 08034 Barcelona).

#### 2. Geographical scope

The scope of the challenge is international.

#### 3. Competition Period

The challenge begins on 1 February 2024 and ends at midnight 3 May 2024.

# 4. The International relations, economics & politics challenge

The Esade International Relations, Economics & Politics Challenge is a competition associated with the Bachelor in Global Governance, Economics & Legal Order and the Double Degree in Law + Global Governance, Economics & Legal Order. The main objective is to detect and reward talented students and facilitate their entry to these programs.

# 5. Participants

The Esade International Relations, Economics & Politics Challenge is open to students who will graduate from secondary school and enter university in 2024 or 2025. Participation in the challenge is on an individual basis.

# 6. Prizes

6.1 The challenge will have one winner and one runner-up. Esade will announce their names on 13<sup>th</sup> May 2024.

- 6.2 The prize for the winner is a 100% tuition bonus for the first year of the Bachelor in Global Governance, Economics & Legal Order or the Double Degree in Law + Global Governance, Economics & Legal Order, if he or she is admitted to one of the above programs. The winner will also have free access to the Esade admissions test.
- 6.3 The prize for the runner-up is a 50% tuition bonus for the first year of the Bachelor in Global Governance, Economics & Legal Order or the Double Degree in Law + Global Governance, Economics & Legal Order, if he or she is admitted to one of the above programs. The runnerup will also have free access to the Esade admissions test.
- 6.4 The winner and the runner-up may renounce the prize but cannot exchange it for another prize or for an amount in cash.
- 6.5 If none of the competition entries submitted meet the eligibility criteria or submission guidelines, the Esade International Relations, Economics & Politics Challenge Committee reserves the right to declare the competition void.
- 6.6 All participants will receive a diploma for their participation in **The Esade International Relations, Economics & Politics Challenge.**

#### 7. Objective of the Competition

- 7.1 The objective of the challenge is for participants to help solve a problem related to climate change in the city where they live. Participants must submit their proposals in the format and dates indicated on the <u>website</u>.
- 7.2 Proposals must be presented in English.

#### 8. Competition jury

8.1 The jury will be composed of Esade lecturers and members of the Esade admissions team.

#### 9. Disqualifications

- 9.1 Participation in **The Esade International Relations, Economics & Politics Challenge** will be on an equal opportunity basis and with strict respect for established rules and good faith.
- 9.2 Accordingly, the following grounds for disqualification are established at the discretion of the organizer:
  - Fraud or falsification in competition registration.
  - Abusive or fraudulent use of the competition rules.



- Rude or offensive behavior towards any participant, or their schools of origin, as well as towards any member of Esade Foundation, or towards the foundation, regardless of how it is expressed.
- Any behavior by participants that could damage the image of the Esade Foundation.

# 10. Applications and deadline

- 10.1 Proposals may be submitted until midnight on 3 May 2024 using the link published on the <u>web</u>. The same website specifies the materials that each participant must submit, as well as the guidelines.
- 10.2 Registration and participation are free of charge and imply a firm commitment to deliver the materials by the established dates and following the detailed guidelines.
- 10.3 Applications received after the deadline, as well as those that are incomplete or do not meet the requirements for participation, will be rejected.

# 12. Acceptance of rules

Submission of an application implies the express and unconditional acceptance of these rules, as well as the waiver of any kind of claim. It also entails the granting of the necessary authorization for the Esade Foundation to incorporate your data into the user file **The Esade International Relations, Economics & Politics Challenge** and to transfer your data to those organizations or persons involved in the organization of the challenge and awarding the prize.

# 13. Interpretation of rules

The organizer of the challenge can resolve any doubts that may arise in the interpretation of these rules and/or in the development of the competition, with the vote of the majority of its components prevailing.

#### 14. Reservations and limitations

The Esade Foundation reserves the right to change, interrupt, suspend, postpone, or cancel the challenge, and to change these rules. If such an event happens before the end of the registration

period, an announcement will be made on the website. Registered individuals will be informed individually. No compensation of any kind will be offered.

# 15. Data protection

Following the provisions of Regulation (EU) 2016/679 and Act 3/2018, and other applicable regulations, the Esade Foundation will create a personal database with the information provided by participants:

- Management: Esade Foundation.
- Purpose: manage the relationship of the participants in **The Esade International Relations**, **Economics & Politics Challenge** with the Esade Foundation; keep participants informed about activities and events; send participants its newsletter and realize its own promotional and advertising activities, as well as to obtain authorization for the registration and use of personal images.
- Legal permission: consent of the persons involved and respect for the legitimate interests of the Esade Foundation.
- Recipients: no data will be communicated to third parties.
- Rights of the interested parties: the rights of access, rectification, deletion, opposition, limitation of processing and portability can be exercised by contacting: Fundación Esade, Avenida de Pedralbes, 60-62, 0803 (Barcelona).

# 17. Applicable law and authority



These rules are governed by Spanish law. Participants in the competition expressly waive any other jurisdiction and submit to the courts of the city of Barcelona for any dispute that may arise.
