### Teaching

EsadeGeo's MOOC on the Coursera platform: Geopolítica y gobernanza global

Since its launch in November 2015, over 20,000 students have enrolled in EsadeGeo's MOOC *Geopolitica y Gobernanza Global*, hosted by Coursera. Over the last two and a half years, however, the global context has undeniably changed – and EsadeGeo has kept up. In July 2018, EsadeGeo launched an updated version of its MOOC, with new content such as two previously unpublished interviews with Javier Solana, a series of videos on the world in 2030, and updated readings on the conflicts in the Middle East and the Iran nuclear deal.



MBA Course: Global Economy and Geopolitics in the 21st Century

#### **OBJECTIVE**

In the increasingly globalised and complex world of the 21st century, it is crucial to understand how major issues on the international stage reverberate in geopolitics, global governance and daily life. This course aims to comprehensively address some of today's most pressing international challenges and, in doing so, to enhance students' capacity for strategic analysis related to these challenges.

#### **FORMAT**

The course comprises eleven sessions. Dr Solana teaches seven of the eleven sessions. For three selected sessions, we invite prominent guest speakers. The 2018-2019 guest speakers were Yu Jie, is Head of China Foresight at LSE IDEAS and lecturer at LSE; Enrique Iglesias, Director of the Latin America Chair at the Universidad Pontificia Comillas-ICADE and Ibero-American Secretary-General from 2005 to 2014; and Christopher Hill, former US Ambassador to four countries (most recently Iraq), and Professor at the University of Denver.

EsadeGeo faculty members Angel Saz-Carranza, Angel Pascual Ramsay and Marie Vandendriessche taught the remaining four sessions.

# Policy Debate

## Seminars & workshops

#### ANNUAL ENERGY MEETING

#### 13 November 2018

The Esade Center for Global Economy and Geopolitics (EsadeGeo) hosted – together with the Representation of the European Commission in Spain, KIC InnoEnergy, the Boston Consulting Group and The Aspen Institute – the 7th edition of its Global Annual Energy Meeting. This meeting provided a forum where business leaders and policymakers could discuss how energy technologies, geopolitics and regulation will affect business and society in the medium term. Among the speakers were José Domínguez Abascal, Secretary of State for Energy of the Ministry for Ecological Transition of Spain; António Calçada, Executive Director of Marketing (Spain, Portugal, Italy and Mexico) of Repsol; and Henrik Hololei, Director General for Mobility and Transport of the European Commission.

In addition, Wilfried Lemmens, CEO of the Royal Association of Shipowners of Belgium; Eduardo Domínguez, Chief of Urban Air Mobility of Airbus; and Mario Armero, Executive Vice President of ANFAC, contributed the technological visions of the key sectors of transport.

The three sessions were moderated by Iván Martén, President of the Boston Consulting Group (BCG) in Spain; Ángel Saz-Carranza, Director of EsadeGeo, and Marie Vandendriessche, Senior Researcher at EsadeGeo.

#### CONFERENCE IN TENERIFE

#### 17 December 2018

On 17 December 2018, Javier Solana delivered a speech at the Real Sociedad Económica de los Amigos del País de Tenerife, entitled "An uncertain world: political, economic and social challenges". He focused on reviewing those events that have been of crucial importance to the 21st century and that still have an impact today.

## "SECURITY AND DEFENCE EUROPE: TOWARD A NEW MODEL" SEMINAR AT ESADE MADRID

14 January 2019

On 14 January 2019, Esade Madrid hosted the seminar "Security and defence Europe: toward a new model" organised by the Spanish committee of LECE, the European League of Economic Cooperation. Former Secretary General of NATO and president of EsadeGeo, Javier Solana, inaugurated the event, which consisted of two sets of panels made up of experts from the European Commission, the European Investment Bank, TEDAE and the Ministry of Foreign Affairs and Cooperation of Spain, among others. The seminar was closed by former Spanish Ambassador to the Philippines and President of the European Security Agency, Jorge Domecq, who stated that the EU needs to have strategic autonomy to be considered a serious security provider and explained EU security initiatives since 2017, especially with regards to seemingly imminent Brexit.





#### ROUND TABLE AT CASA DE AMÉRICA WITH JAVIER SOLANA AND SUSANA MALCORRA

17 January 2019

As part of the roundtable cycle "America Voting", organized by Casa de América on the elections in several American countries in 2019 and the changes after the US elections of 2016, Javier Solana participated on 17 January 2019 in the discussion on "USA and the crisis from the West: what can Latin America and Europe do?" with the former Argentine foreign minister Susana Malcorra. Throughout the discussion, the speakers exchanged views on the current state of international relations, with reference to the United States, China, Europe, Latin America and the Middle East. The starting point of this world tour was Washington DC, plunged into a legislative "impasse" that coincides with the half-way point of Trump's mandate, when he is at loggerheads with the new House of Representatives and its Democratic majority (achieved in the midterm elections in November), regarding the financing of the promised border wall with Mexico. Palacio began the debate by referring to the "weakening of the western pillars" and the fragmentation of the international order, which are being exacerbated by the Trump Administration's unwillingness to occupy the leadership role that America has traditionally played in multilateral institutions. For Javier Solana, the "America First" that Trump defends is an "insane" stance in a globalized, interdependent world in which "strategic trust" is much needed. Faced with this situation, the veteran politician pointed out the paradox of the US controlling the World Bank.

Moreover, Susana Malcorra lamented the excessive attention given by the media to the figure of the President, claiming that the nationalist-populist trend is a "shock wave that goes far beyond Trump."

#### "WAR & PEACE IN THE 21<sup>ST</sup> CENTURY: CITIES AS PLACES OF REFUGE AND PROMOTERS OF PEACE" AT CIDOB

19 January 2019

On 19 January 2019, Javier Solana attended the seminar "War & Peace in the 21st Century: Cities as places of refuge and promoters of peace" at CIDOB, to discuss the important role of cities in violent conflict, focusing on their dual role as, on the one hand, managers of vulnerability and places of refuge and, on the other, promoters of reconstruction and peace. The event was attended by Helen Clark, former Prime Minister of New Zealand and UNDP Administrator; Juliana Kerr, Director of Global Cities and Immigration at the Chicago Council on Global Affairs; Gerardo Pisarello, First Deputy Mayor of Barcelona City Council; and many others.

## THE WORLD TODAY: POLITICAL, SOCIAL AND ECONOMIC CHALLENGES

5 February 2019

On 5 February 2019, IBEI organized a conference featuring Prof. Javier Solana, President of EsadeGeo, within the framework of the H2020 project "Global Governance and the European Union: Future Trends and Scenarios (GLOBE)".

GLOBE addresses the strategic priorities identified in the EU Global Strategy such as trade, development, security and climate change as well as migration and global finance, in order to identify the major roadblocks to effective and coherent global governance by multiple stakeholders in a multipolar world. The project recommends strategies on how the EU might promote enhanced global governance and deal with future challenges and gridlocks.





## #BIGCHALLENGES CYCLE: ENRIQUE V. IGLESIAS AND JAVIER SOLANA DISCUSS THE FUTURE OF LATIN AMERICA

#### 7 February 2019

Former Ibero-American Secretary General Enrique V. Iglesias visited ESADEFORUM on 7 February 2019 and conversed with Javier Solana on different options to resolve the situation in Venezuela: "The opinion of Cuba is very important, which also played a very important role in the pacification of Colombia".

# XXVI BIENNIAL CONGRESS OF WORLD JURIST ASSOCIATION: CONSTITUTION, DEMOCRACY AND FREEDOM. THE RULE OF LAW, GUARANTOR OF FREEDOM

19 - 20 February 2019

On 10-20 February 2019, the XXVI Biennial Congress of the World Jurist Association took place in Madrid, and the President of EsadeGeo, Javier Solana, participated as a speaker at a panel discussion entitled "Multilateralism as a requirement of political and economic globalization". For the two days of the congress, the debate focused on "The Rule of Law as a Guarantor of Freedom" and the analysis of these issues that form part of the United Nations agenda for 2030. The congress brought together members of the judicial, business and institutional landscape, both nationally and internationally. One of the highlights was the ceremony of the WJA World, Peace & Liberty Award to His Majesty the King of Spain.

## HOW TO ADVANCE IN THE ACHIEVEMENT OF THE SDGS? TOWARDS A SUSTAINABLE SPAIN

28 February 2019

After more than three years since the UN approved the Sustainable Development Goals, Esade organized this discussion on its implementation to date and the challenges for achieving sustainability by 2030.

The 2030 Agenda is a collective and universal responsibility that encompasses all actors and sectors. The main conclusions of the report – which was approved by the European Union and in which Esade participated – were presented. This round table comprised representatives from the public sector, the private sector, and from NGOs.

## #BIGCHALLENGES CYCLE: THE NEW GLOBAL ROLE OF THE UNITED STATES: HAS U.S. FOREIGN POLICY REACHED A POINT OF NO RETURN?

6 March 2019

On 6 March 2019, another chapter of the Big Challenges cycle took place at Esade, analyzing the new global role of the United States. We hosted our international guest Christopher Hill, former US Ambassador to four countries (most recently Iraq), who came as a representative of the University of Denver, and held a dialogue with the President of EsadeGeo Javier Solana. The dialogue gave a voice to opinions on the immediate future of international relations in a post-Trump era and different scenarios. They reviewed the current political situation and issues raised by countries, such as Russia, China, Iran and North Korea, with which Ambassador Hill has a direct relationship since he was Head of the U.S. delegation to the Six-Party Talks on the North Korean nuclear issue.



## INTERNATIONAL AND EUROPEAN PERSPECTIVES ON TRADE IN GLOBAL GOVERNANCE

12 April 2019

EsadeGeo joined the "International and European Perspectives on Trade in Global Governance" panel in Brussels on 30 April 2019. This initiative is part of the GLOBE Project ("Global Governance and the European Union: Future Trends and Scenarios"), funded by the European Commission's Horizon 2020 program, which addresses the strategic priorities identified in the EU Global Strategy. The project, coordinated by the Institut Barcelona d'Estudis Internacionals (IBEI), was run mainly from Barcelona, where three of the ten partners are located: Esade, Barcelona Institute of Global Health (ISGlobal, center promoted by "la Caixa") and IBEI. The event featured panelists Sandra Gallina (Deputy Director General, DG Trade); Miles Kahler (Professor, American University and Senior Fellow, Council on Foreign Relations); Qingmin Zhang (Professor, Peking University); and Samuel Sam-Sumana (politician and former Vice President, Sierra Leone).

The debate focused on the complex dynamics that are reshaping the global trading system, in order to understand global perspectives on the recent major structural and political challenges to this system. It also looked at the intersection of trade and global governance in uncertain times.

## DIALOGUE BETWEEN JAVIER SOLANA AND BRANKO MILANOVIC. INEQUALITY AND THE FUTURE OF CAPITALISM

17 May 2019

On 17 May 2019 Esade Madrid hosted a dialogue between Dr. Solana and Branko Milanovic, one of the world's leading experts on inequality, about security and the future of capitalism.

In this session, Milanovic declared: "What's crucial now is not the number of years of education that a state can guarantee, but rather the state's ability to balance the quality of that education". Prof. Milanovic also stressed the need to "redefine the goals of societies from a social-democratic point of view in order to ensure that the various types of economic allocations are more equitable and there are no longer such marked differences between business owners and workers". He also added: "We need to achieve an egalitarian form of capitalism in which wealth is distributed more equitably and people are less dependent on the welfare state".

## DECARBONIZING THE ENERGY SECTOR AND INDUSTRY: THE ROLE OF CC(U)S

16 May 2019

How can we shift from talking about energy-transition scenarios to implementing policies that lead to real changes in the energy system worldwide? The issue is a thorny one because one has to go beyond just focusing on the long-term benefits of a low-carbon economy. One also needs to strike a balance between the competitiveness of economies, universal access to energy and the sustainability of energy supplies. These were some of the main issues arising in the session "Energy Transitions: Going Beyond the Scenarios", which was held at Esade by EsadeGeo. The experts discussing them were: Spain's Secretary of State for Energy Daniel Navia; Repsol's CEO, Josu Jon Imaz; and Professor and expert in international energy policy at the School of Global Policy & Strategy (GPS) at the University of California, San Diego (UCSD), David G. Victor. The session was chaired by Javier Solana, President of EsadeGeo.



## CHINA-EUROPE FORUM ON REFORM AND GLOBALISATION

22 November 2018

On 22 November 2018, China Daily (in collaboration with the China Institute for Reform and Development, and EsadeGeo) held the China-Europe Forum on Reform and Globalisation, in collaboration with the China Institute for Reform and Development, and EsadeGeo. The event brought together over 30 experts to debate links between China and Europe, the reforms of the Asian giant, strategic relations between Spain and China, and China's economic development and globalisation.

The Forum was attended by over 30 experts in world politics and economics. Keynote speakers included José Luis Rodríguez Zapatero, former President of the Spanish Government; Wang Xiaohui, Deputy Head of the Publicity Department of The Central Committee of The People's Republic of China (PRC) and Deputy Director of the Policy Research Office of The Central Committee; Liu Shijin, Vice-President of the Research Foundation for China's Development (a State Think-Tank); Lyu Fan, Chinese Ambassador to Spain; and Bernard Dewit, President of the Belgium-China Chamber of Commerce.

The experts at the Forum stated that China had entered a new stage of economic maturity and was transforming its consumer market and thus sought Spain's help to achieve its goals in these fields. Both countries are seeking new kinds of collaboration in areas such as tourism, cultural activities, and innovation. China is also increasingly interested in Small and Medium-sized Enterprises (SMEs) given that these are the 'invisible champions' of the business sector. These companies have long histories and a much smaller volume of production but they are the best in their respective sectors and produce more sophisticated products.

## XXXI INTERNATIONAL SECURITY AND DEFENSE SEMINAR. NATO: THE VERTIGO OF THE AMERICAN WITHDRAWAL

11 – 12 June 2019

On the 70<sup>th</sup> anniversary of the signing of the Washington Agreement and the 20<sup>th</sup> anniversary of the membership of three Warsaw Pact countries (Poland, Hungary and the Czech Republic) in the North Atlantic Treaty Organization, the Association of European Journalists analyzed the current status of the Treaty. The discussion took place in Toledo on 11 and 12 June 2019.

On 11 June 2019, EsadeGeo's President, Javier Solana, moderated the fourth session entitled "Big challenges of NATO" comprising of Sylvie Matelly (Associate Director of The French Institute for International and Strategic Affairs); General Francisco José Dacoba; Svetlana Bokeriya (Associate Professor at RUDN University in Moscow); and Georgina Higueras (journalist and writer). What are NATO's key current challenges? What role will cooperation play? Is the internet the new stage? What relations would it be advisable to maintain with Russia? These were some of the issues addressed.

#### EUROPA ¿QUO VADIS?

20 June 2019

On 20 June 2019, EsadeGeo's President Javier Solana took part in the conference "Europa ¿quo vadis?" at Espacio Bertelsmann. Five other outstanding figures took part in the event: Francisco Belil (Vicepresident of Bertlesmann Fundation); Francisco Fonseca (Director of the Delegation of the European Commission in Spain); Isabell Hoffmann (expert researcher at the Bertelsmann Stiftung and Manager of EUPINIONS); Salvador Llaudes (researcher at Real Instituto Elcano); Pol Morillas (Director of CIDOB); and José Ignacio Torreblanca (Director of ECFR).

Dr. Solana's session focused on the future of Europe and he underlined the need for "going back to the origins of the EU". His opening speech looked at "A vision of the future of Europe".

#### SUMMER DRINKS & A TALK WITH ANGEL SAZ IN DC

19 June 2019

On 19 June 2019, EsadeGeo's Director, Angel Saz, met with Esade Alumni at Georgetown to talk about the EU's current political fault lines.

#### SUMMER MEETING - UNIVERSITY OF VALLADOLID

18 July 2019

On 18 July 2019, Javier Solana opened the First Summer Meeting organized by the University of Valladolid on July 18, 19 and 20.

His speech focused on the collapse of the European dream caused by the Brexit and he was followed by Dr. Pedro Olalla, a Spanish writer and Hellenist, who analyzed the Greek political situation. Professor Jesús Quijano chaired the session.




