### 1st Year

---

#### INSTITUTIONS & DECISION-MAKING

This course enables you to understand how institutions interact and how different forms of decision-making give rise to social, political, and economic solutions that reveal significant differences.

#### CONTRATACIÓN PRIVADA

In this class, we will address whether contracts, based on the principle of autonomy of will, can have any content desired by the parties, or if, in addition to respecting legal limits, contractual agreements should have a minimum content of justice, either in economic or social terms

#### STRATEGIC THINKING FOR GLOBAL GOVERNANCE

Climate change Governance from the perspective of Game Theory. All indicators point out that the efforts done to reduce CO2 emissions are below what we need to ensure that climate change is not a threat to the World, our planet or our societies. Why individual players, some governments, do not engage in more concrete actions? Climate Change can be analyzed as a prisoner's dilemma prisoner although it may be more complex than this model. This session has two parts: the analysis of the empirical evidence about the Climate Change situation and a second part about how Game Theory can help us to explain not only what is happening, but also how it can be addressed.

---

#### SELF-DETERMINATION & MINORITY RIGHTS

This course explores the evolution of the concept of self-determination from the nineteenth century to the present. The focus is on changing legal norms, including interpretation of the principle of self-determination by the League of Nations and the United Nations. The seminar adopts a case-study methodology combined with lectures.

#### DERECHO PROCESAL PENAL

#### INTERNATIONAL HUMAN RIGHTS PROTECTION

Human rights have become a central pillar of the international order and are enshrined as fundamental rights in most constitutional states. The course serves as an introduction to international human rights protection, delving into governance approaches, public international law, and international politics. We will begin with a brief overview of the historical development and the nature of human rights. Subsequently, we will discuss relevant actors, protection mechanisms, compliance, and enforcement, along with critiquing human rights.
